Miriam School

Miriam School program was founded more than 50 years ago on the belief that every child possesses unique talents and abilities that can be strengthened within the appropriate educational environment. The school program is designed for children in pre-kindergarten through eighth grade who have learning, speech/language, sensory/motor and attention disabilities.

Through a team approach, small class size and specialized instruction, Miriam School provides a variety of accommodations and curriculum modifications designed to meet the academic needs and support the social skills development of each child.

Miriam School had an enrollment of 87 students in the 2009–10 academic year and graduated six eighth graders. Support from generous donors provided more than \$600,000 in scholarship support to 52% of our students.

Miriam Learning Center

Miriam Learning Center opened in 2007 to serve as a resource for specialized services for students, ages four through 18, all over the St. Louis region. The Center offers assistance for every stage of education from preliminary disability testing to the execution of a customized learning plan.



In the three years since it opened the Center has helped nearly 500 students and their families discover new and innovative ways to deal with their unique challenges. A full curriculum of comprehensive services, convenient evening and weekend hours, and year-round programming ensure that students can cultivate their capabilities and that the learning never ends.

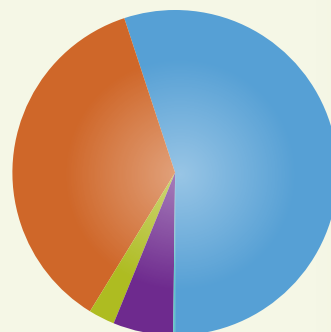
The Miriam Foundation improves the quality of life for children with learning disabilities and their families through innovative and comprehensive programs.

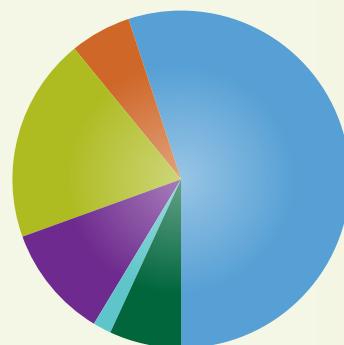
